- Mrs. Nicholson welcomed the council members and introduced Johnny Burleson with Creative Fundraising Advisors. Mr. Burleson started with an overview of the scope of work he is doing for P20 and continued on with his presentation, which can be found here. The following areas of his presentation were discussed:

- Dr. Loflin asked about the adult learner impact of our work as it relates to the work CFA is doing. Mr. Burleson said he would need to review the feedback and would get back to P20 on that.
- Mrs. Martin believes that the workforce goals are more long term goals, with early-ed falling more towards short term goals. It was then discussed how P20 manages all the areas of need from 'P' to '20". From a sustainability perspective the funding for the 'P' is very different from the funding sources for the '20'.
- Mrs. Smith asked if the other P20 organizational models could help bring guidance.
 Mrs. Nicholson went through the various other models and our's is the only collaborative effort.
- The discussion continued with comments about the importance of identifying essential goals, more participation from all council members and the importance of storytelling to create more involvement. that in P20 can't market the work we are doing, if it only involves 10% of those on the council.
- Mrs. Nicholson reminded the group that P20 is unique in that our funders want to participate, which is rare. She then asked if there are any objections or further comments on Mr. Burleson's presentation.
- Dr. Loflin thinks the 2025 timeline seems a bit aggressive. Mrs. Nicholson asked if we think the whole council needs to be involved with the creation of a new strategic plan. Mrs. Martin does not think so, rather a select group of members. Mr. Burleson recommended a strategic planning committee be created with current and non-current council members, possibly incorporating select original members. Dr. Cheeks is worried about the Pre-K demographic in the plan and how it fits in. Dr. Loflin reminded the group of the Pre-K reports stating that change either cost money or legislative modifications, which is outside of the work that P20 can effect.
- Ms. Hartley mentioned how the myFutureNC 2030 goals are similar at the state level with the work P20 is doing regionally. Dr. Cheeks expressed her desire to get the superintendents involved with P20. Everyone agrees, and also understands what they all have on their plates already.

- NC currently has no way to count credentials, so the NC Workforce Credentials Advisory Council was established. Dr. Cheeks asked if high school credentials will be counted and Ms. Hartley replied that apprenticeships will be but she is not sure if others will. Mrs. Nicholson see's the NC Advisory Council being something P20 could possibly help with. Mrs. Smith asked what the deadline is to have current credential information to reference and if P20 should consider using that while the strategic plan is being created. Ms. Hartley does not know when the initial findings will be completed, but will reach back out to Mrs. Nicholson and let her know.
